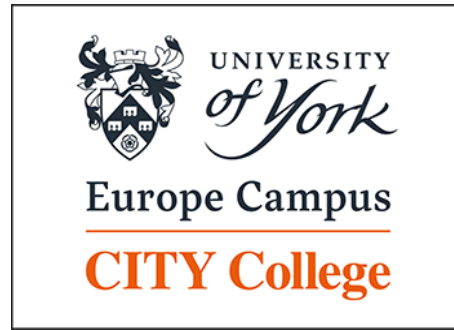

ANNOUNCEMENT

Entry Scholarships

**to CITY College, University of York Europe Campus
for students from the Republic of Srpska, 2021-22**

For:

- **Undergraduate (Bachelors)**
- **Postgraduate (Masters full-time)**
- **Executive MBA (part-time)**

CITY College, University of York Europe Campus in cooperation with the **Representative Office of the Republic of Srpska in Greece** are offering fifteen (15) half tuition fee scholarships to students from the Republic of Srpska for Bachelors, Masters (full-time), and the Executive MBA (part-time / weekend or blended mode) studies, starting from the academic year 2021-2022, until the end of the specific academic programmes.

Under this initiative, CITY College has agreed to support tuition of exceptional students who wish to study at CITY College, University of York Europe Campus in Thessaloniki, Greece and pursue a globally recognized degree from University of York. The studies will be offered at CITY College, University of York Europe Campus in Thessaloniki, Greece. Optionally, beneficiaries of the Pan-European Executive MBA programme, may choose to attend the MBA programme offered in Belgrade, Serbia or the Blended Mode MBA programme.

[CITY College, University of York Europe Campus](#) is the physical presence and an integrated part of University of York. It is an international hub for inspiring learning and advanced research, while it presents a gateway for students and scholars, especially in the post-Brexit era. It is the

first campus of a UK university in South-East Europe, which provides the highly acclaimed British education in the region of South-East Europe and beyond.

[University of York](#) is a prestigious British university, and a member of the Russell Group. It is one of the world's premier institutions for life-changing research and excellent teaching. It has been awarded Gold for "outstanding teaching, learning and outcomes for students". This focus on teaching and research excellence has resulted in consistently high rankings of University of York in the UK and a first-class reputation across the globe.

AWARD AMOUNT

The Representative Office of the Republic of Srpska in Greece and CITY College, University of York Europe Campus have agreed to offer a total of fifteen (15) half tuition fee scholarships.

THE HALF TUITION FEE SCHOLARSHIPS (50%) ARE OFFERED FOR:

- 1. UNDERGRADUATE PROGRAMMES (BACHELORS)**
- 2. POSTGRADUATE PROGRAMMES (MASTERS)**
- 3. MASTER OF BUSINESS ADMINISTRATION PROGRAMME (MBA)**

These half tuition fees scholarships (50%) are as follows:

Five (5) half tuition fee waiver scholarships for **undergraduate studies** (3 years of study), according to the following scheme:

50% of the tuition fees will be covered by CITY College (4,120 Euros per student per year, currently undergraduate yearly tuition fees are 8,240 Euros)

50% of the fees will be covered by the student (4,120 Euros per student per year)

Five (5) half tuition fee waiver scholarships for **postgraduate full-time studies** (1 year of study), according to the following scheme:

50% of the tuition fees will be covered by CITY College (5,340 Euros per student, total postgraduate tuition fees are 10,680 Euros)

50% of the fees will be covered by the student (5,340 Euros per student)

Five (5) half tuition fee waiver **MBA scholarships for the public and private sector employees**, (2 years of study), according to the following scheme:

50% of the fees will be covered by CITY College (4,473 Euros per student, per year, currently executive MBA tuition total fees for 2 years are 17,890 Euros)

50% of the fees will be covered by the student (4,472 Euros per student per year)

The Bachelors studies last 3 years.

ELIGIBILITY FOR THE BACHELORS SCHOLARSHIPS

Candidates for the Bachelors Scholarships should meet the admission requirements of CITY College, University of York Europe Campus programmes for which they are applying.

Candidates eligible for the undergraduate programmes should hold a High School Graduation Certificate.

Candidates must have fluent command of the English language (TOEFL: internet based 79 or IELTS: 6,0 or equivalent qualifications). Candidates who do not possess at the time of the application any of the above mentioned English Language Qualifications are eligible for the scholarships provided that they take the University's English Language Test, which will be organized by the University in the Republic of Srpska or online before the final selection of the scholars. However, after being accepted to the programme of their interest, the scholars must take the IELTS or TOEFL exams during the first year of studies at CITY College and achieve the required score (TOEFL: internet based 79 or IELTS: 6,0).

Students who have completed all their school studies through the medium of the English Language are not required to submit an English Language Qualification.

ELIGIBILITY FOR THE MASTERS SCHOLARSHIPS

Candidates for the Masters Scholarships should meet the admission requirements of CITY College programmes for which they are applying.

Candidates eligible for the postgraduate programmes are normally expected to hold, or to be about to achieve, a good Class Honours Bachelor's Degree from an accredited University or an accredited college.

Candidates must have fluent command of the English language (TOEFL: internet based 89 or IELTS: 6,5 or equivalent qualifications). Candidates who do not possess at the time of the application any of the above mentioned English Language Qualifications are eligible for the scholarships provided that they take the University's English Language Test, which will be organized by the University in the Republic of Srpska or online before the final selection of the scholars. However, after being accepted to the programme of their interest, the scholars must take the IELTS or TOEFL exams during the first semester of studies at CITY College and achieve the required score (TOEFL: internet based 89 or IELTS: 6,5).

Students who have completed their undergraduate studies through the medium of the English Language are not required to submit an English Language Qualification.

MASTER OF BUSINESS ADMINISTRATION (MBA)

University of York Europe Campus, CITY College offers **The Pan-European Executive MBA** programme. This is a highly acclaimed programme, which has been designed exclusively for experienced business executives and professionals that wish to pursue high quality education in line with their professional, career and personal development goals without interrupting their working engagements.

[The Pan-European Executive MBA](#) programme is taught during nine long weekends (Friday, Saturday and Sunday), about once a month. The duration of the programme is 24 months including the Dissertation / Industrial Capstone Project.

Students can choose to study for the Executive MBA in two ways:

- *The Executive Mode*: 8 face-to-face, in-class delivery of courses, locally, and 1 course delivered online, plus three international study trips

OR

- *The Executive MBA Blended Mode*: synchronous online delivery of all 9 courses plus three international study trips

The scholarships are available for the following specializations of the Executive MBA (EMBA) programme:

- MBA in General Management
- MBA in Marketing
- MBA in Finance
- MBA in Logistics and Supply Chain Management
- MBA in Healthcare Management
- MBA in Human Resource Management

IMPORTANT: Face-to-face or Blended delivery mode

Beneficiaries of the scholarships may choose between the Executive Mode (face-to-face delivery plus 3 study trips) or the Executive Blended Mode (synchronous online delivery plus 3 study trips).

In case they choose the Executive Mode (face-to-face), they may also choose to attend either the programme offered in Thessaloniki, Greece or the programme offered in Belgrade, Serbia.

ELIGIBILITY FOR THE MBA SCHOLARSHIPS

Candidates for the MBA Scholarships should meet the admission requirements of CITY College programmes.

Candidates eligible for the Executive MBA programmes are normally expected to hold a good Honours Bachelor's Degree from an accredited University or an accredited college.

Candidates must have a fluent command of the English language (TOEFL: internet based 89 or IELTS: 6.5 or equivalent qualifications). Candidates who do not possess at the time of the application any of the above mentioned English Language Qualifications are eligible for the scholarships provided that they take the University's English language Test, which will be organized by the University in the Republic of Srpska or online before the selection of the scholars.

Students who have completed all their undergraduate studies through the medium of the English Language are not required to submit an English Language Qualification.

A minimum of three (3) years work experience is required.

Notes:

The scholarships **cover the tuition fees and registration fees**. Students should therefore cover their travel, accommodation, and their living expenses with their own finances.

If a student-recipient of a scholarship does not attend the programme for any personal or other reason, then a student from the runner-up list will replace him / her. The Representative Office of the Republic of Srpska in Greece and CITY College will agree on student replacements also in other cases, **whereas the selection of scholarship students will be made by the University.**

If a student, due to health or other emergency reasons, requests temporary suspension of studies, the Representative Office of the Republic of Srpska in Greece and CITY College shall establish a committee to verify the suspension request: the committee shall approve or turn down the request based on facts.

The students admitted on condition (i.e. cases pending to receive their high school certificate or university diploma) shall be obligated to submit it to the University the latest by 15 September, otherwise they will be replaced by other students in the ranking list.

Additional terms:

1. CITY College, University of York Europe Campus should provide The Representative Office of the Republic of Srpska in Greece with information regarding the scholars' progress.
2. The Representative Office of the Republic of Srpska in Greece and CITY College, University of York Europe Campus both agree that students who fail their academic year will lose their scholarship right.
3. All scholars will sign a study contract with the Representative Office of the Republic of Srpska in Greece according to the regulations set by CITY College.

APPLICATION PROCEDURE AND DEADLINE

The application deadline for the Bachelors, Masters, and MBA scholarships is on:

The Representative Office will in turn submit them to CITY College, University of York Europe Campus.

Along with their application form, candidates should also submit ALL the required qualifications (copies of the originals with official translation in English, all certified as genuine copies), as specified in the relevant Admission and Application Requirements (see links above).

Those who have not graduated yet but expect to have graduated by 15 September 2021 should submit all their available transcripts so far. The Scholarships Committee will decide on the basis of the academic proofs available at the time of selection.

When you submit the Application Form and the required documents, make sure you mark clearly your name, telephone, email, and programme of interest.
